D E A R F R I E N D S :

Thank you for joining us tonight to celebrate 40 years of Philadelphia VIP!

When the leadership of the Philadelphia Bar Association tapped a small cohort of service-minded private attorneys in 1981 to mount a local response to the massive federal funding cuts to legal services agencies around the country, the expectation was that the resulting initiative—the Philadelphia Lawyers Volunteer Action Program (PLVAP) would serve as a temporary supplement to the critical work of established legal aid organizations that had been affected by those cuts.

But the need for free legal services on a large scale persisted through the years, and therefore so did the work of PLVAP. By 1985, through the collaboration of Bar Association Chancellor Bennet G. Picker and a handful of visionary attorneys including Carl “Tobey” Oxholm III and Eve Biskind Kloth, PLVAP evolved into the more mellifluously named Philadelphia VIP, with Eve as its first Executive Director, and remains today a bastion of community empowerment in Philadelphia.

Some four decades later, the great need for legal services in Philadelphia continues, as does the spirit of collaboration at the heart of VIP’s founding, and its sustained success in helping its clients secure their basic human needs. That spirit of collaboration can be found in the relationships between VIP volunteer attorneys and the clients they work to empower, between those volunteers and VIP’s brilliant, hardworking staff—today led by Executive Director Rida Haq, who has steered the organization through the tumult of the past two years with unflagging grace, grit, good humor and clarity of purpose—and most essentially, between Philadelphia’s private and public interest bars. It is this first of its kind collaboration that has made VIP a lasting and national model for legal services organizations in the 21st century.

Tonight, as we celebrate Philadelphia VIP’s 40th anniversary—a milestone made possible thanks to you—we envision a day when all will have equal access to justice. But until that day arrives, we remain grateful for your generosity, your support and your dedicated collaboration in the years to come.

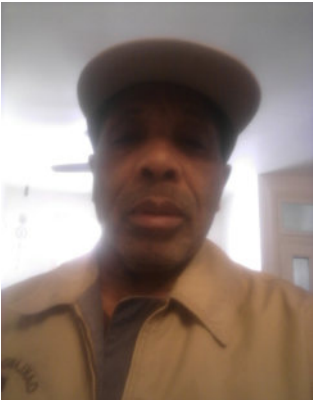

Robert Blanton

Mr. Blanton had lived in his home for over forty years, but the home was not in his name. The only way to become a homeowner was to pursue adverse possession – a complex and costly process, and one that's virtually impossible without a lawyer's help. VIP found Mr. Blanton a volunteer to pursue adverse possession, and as a result, he owns his home. He is currently working with a volunteer to draft a will so he can pass his wealth to the next generation.



Shands Cleaning Company LLC

Alonzo Shands encountered VIP at a Small Business Legal Clinic, and over the next several years, he returned to VIP for help with multiple legal issues related to his family cleaning business. VIP volunteers assisted with drafting waivers, reviewing corporate documents, and, notably, answering emergent pandemic-related questions during COVID shutdowns. Thanks to his volunteers' help, Mr. Shands' small business has weathered the pandemic and continues to operate securely.



U.S. Congresswoman Mary Gay Scanlon

Congresswoman Mary Gay Scanlon has been the U.S. Representative for Pennsylvania's 5th District since 2018. A staunch believer that everyone is entitled to equal protection under the law, Congresswoman Scanlon previously worked as national pro bono counsel at a Philadelphia firm, where she directed over 600 lawyers in providing more than 50,000 pro bono hours annually. In that capacity, she was instrumental in serving hundreds of small business and nonprofit clients by organizing VIP legal clinics at her firm. In addition, she carried her own VIP guardianship caseload.
